- 1. BRANCH REPRESENTATION** – each Branch within the Command is entitled to representation at the Convention by one (1) Delegate for the first Fifty (50) Ordinary, Life, Associate and Affiliate Voting Members or fraction thereof and one (1) Delegate for each one hundred (100) voting members or fraction thereof based on the Per Capita Tax paid to the end of December 2018 and received at Dominion Command.
- 2. QUALIFICATION OF DELEGATES** – each Delegate appointed must be an Ordinary, Life, Associate or Affiliate Voting Member whose Per Capita Tax is paid for the year 2019. Each Delegate must be accredited on an Official Credential Certificate completed by the Branch which they represent or Nova Scotia/Nunavut Command.
- 3. PROXY REPRESENTATION** – A Branch may be represented by “Proxy” through a Delegate accredited by the Branch to which he/she is a Member within their respective District/Zone. All proxy holders must be named on the Credential Certificate completed by the Branch which they are to represent. Proxy holders may carry up to four (4) proxy votes from the Branch of which he/she is a member, or if an accredited delegate of his/her own Branch, any other Branch within his/her District/Zone.
- 4. OFFICIAL CREDENTIAL CERTIFICATE** – An official Credential Certificate naming accredited Delegates and/or Proxy holders is enclosed. This Certificate is to be completed and submitted to the office of the Executive Director, Nova Scotia/Nunavut Command, via post at 61 Gloria McCluskey Ave., Dartmouth, NS; B3B 2Z3; or, via e-mail at [info@ns.legion.ca](mailto:info@ns.legion.ca); or, via fax at 902-429-7481; to be received not later than April 17 2019. Credential Certificates should be submitted as soon as possible after Branch delegates are chosen.

**The Official Credential Certificate must be submitted signed by the Branch President and Secretary whether or not a Branch is sending delegates.**

5. **RESOLUTIONS** – Further to previous notices please be advised that notices of, and copies of, all resolutions for submission to the 2019 Nova Scotia/Nunavut Command Convention, must be received by the office of the Command Secretary not later than January 07 2019.
6. **ACCOMMODATION** – Delegates are responsible for booking accommodation.

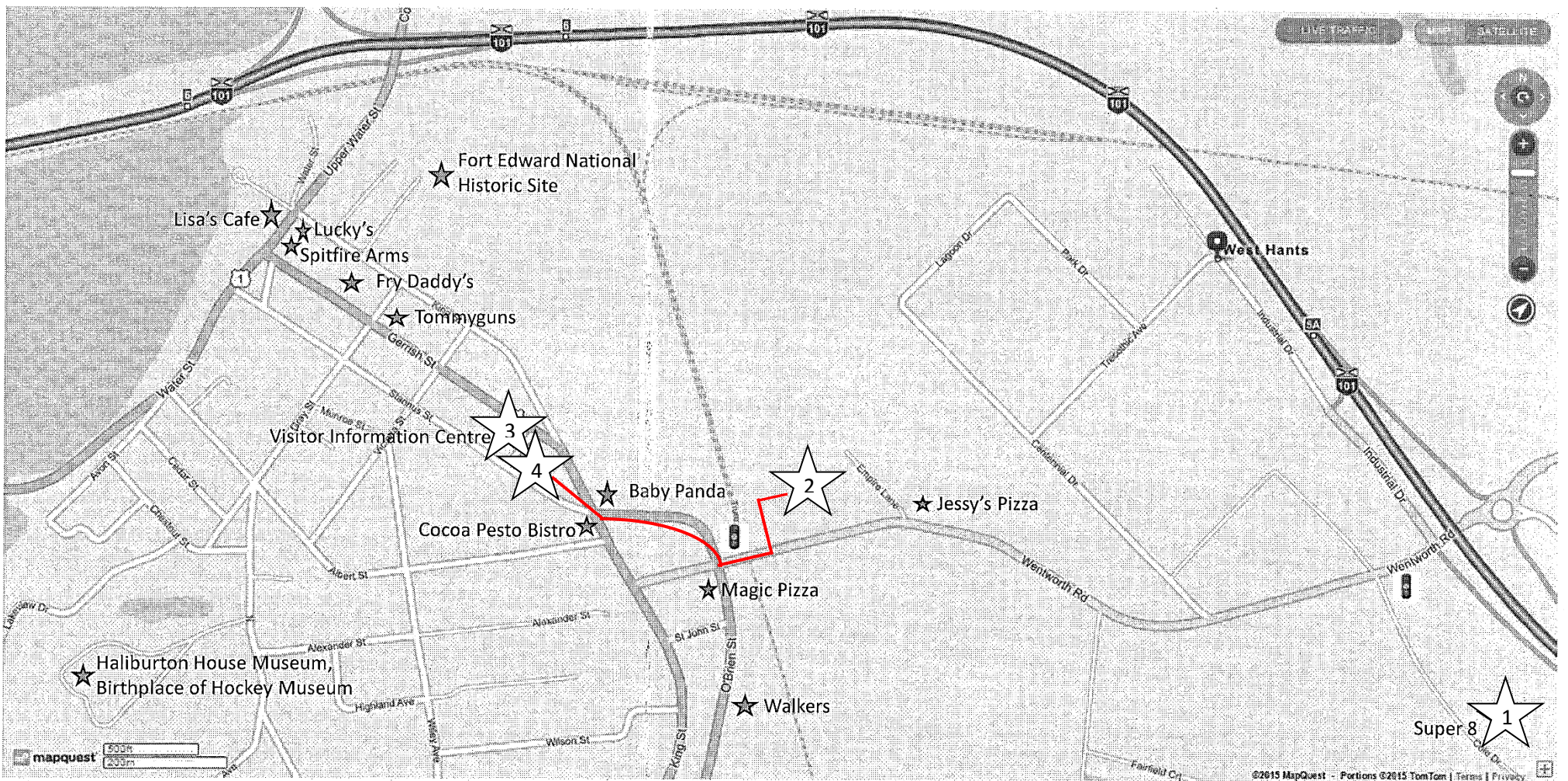
