Branch Financial Assistance

There currently is approximately 85K available through NS/NU Command for branch financial assistance.

Branches may apply now for this funding. There is no minimum amount.

These funds are intended for branches which are in real need of funds to stay afloat for the next 6 months. Approval will be based on financial need.

Criteria for applying;

- a. Operations costs that are essential to keep the branch from closing. i.e. insurance, utilities (heating, electricity, water, phone, etc), mortgage or loan payments, contractual obligations such as snowplowing, bookkeeping, cleaning & garbage removal.
- b. Repairs items that are necessary to preserve the integrity of the facility or required for safety.

Branches are required to apply using the attached form as soon as possible but not later than 1:00 pm April 06 as there are only a limited amount of funds to disburse. Branches must submit application utilizing the attached form directly to Command Office by email at info@ns.legion.ca, by mail 61 Gloria McCluskey Ave., Dartmouth, NS; B3B 2Z3 or by fax 902-429-7481. NS/NU Command will supply copies of all applications to applicable District and Zone Commanders.

An Ad Hoc Committee from Command will assist District and Zone Commanders in identifying branches that may possibly need assistance. This committee is also willing to assist branches in applying if required.
