Nova Scotia/Nunavut Command Chairman Karen Lynch, called the NS/NU Command Executive Council Meeting to order at 9:02 am.

1. OPENING RITUAL

1st Vice President Jay Tofflemire conducted the Opening Ritual.

2. Introductions/Welcome

Nova Scotia/Nunavut Command Chairman Karen Lynch, called on those present to introduce themselves.

3. Agenda/Procedures

Nova Scotia/Nunavut Command Chairman Karen Lynch, advised those present of the Agenda and Procedures for the meeting.

4. Presidents' Remarks

NS/NU Command President Mel Crowe addressed the meeting stating that NS/NU Command business will continue to be operated in an open transparent team oriented manner. Canada 150 Medal

NS/NU Command President Mel Crowe advised that he received a request to have the Canada 150 medal presented to each member of the 2015-2017 Executive Council. Discussion resulted in the following:

The meeting was advised that the Canada 150 lapel pin is not permissible to wear on Legion dress.

416.A

District C Commander Robert Hoeg pointed out that in accordance with NS/NU Command By-law 416.A, Districts or Zones shall elect or appoint a Deputy District or Zone Commander. He stated that given that the position is prescribed by by-law, Deputy District Commanders should be awarded that service medal by NS/NU Command.

That Deputy District Commanders be awarded the medal of office by NS/NU Command effective for the term ending May 2019.

11 Affirmative 0 Abstention 0 Opposed **Motion Carried** It was agreed that in time for the 2019 Convention, District Commanders would make the Honours and Awards Committee aware of the names required, for the 2017-2019 term, of those who do not already have this medal.

814.C

NS/NU Command 1st Vice President Jay Tofflemire advised that the proposed change to NS/NU Command By-law 814.C, inadvertently, was not ratified by Convention although the change was agreed to by Executive Council. Discussion ensued resulting in the following:

NS/NU Command Chairman Karen Lynch determined that the motion was out of order given that it would then contradict NS/NU Command By-law 706.

That NS/NU Command continue, in accordance with 814.C, as agreed to by Executive Council previously and that the matter of ratification of 814.C be dealt with appropriately at the 2019 Command Convention.

Host 2018 Cribbage

Comrade Robert Hoeg, on behalf of the Sports Committee advised the meeting that Branches 111, 38, 26 and 9 have applied to host the 2018 Cribbage. As all applicants were considered to be most suitable Comrade Hoeg conducted a draw to determine the host Branch for 2018. NS/NU Command Zone 2 Commander George Dellavalle drew Branch 38 as host Branch and Branch 111 as alternate.

NS/NU Command Signing Officers

President Crowe advised the meeting that signing officers of Command would remain as status quo in the short term. The meeting expressed agreement with this arrangement. President Crowe noted that when signing authority is finalized Executive Council will be informed.

Business Cards

NS/NU Command President Crowe requested that Executive Council Members requiring re-supply of business cards, those requiring business cards, and, those requiring change to business cards please contact the Executive Director.

President Crowe reviewed several invitations to events received by Command advising that where possible he would attend and/or have a Command Executive Council Members represent Command on these occasions.

NS/NU Command Immediate Past President Steve Wessel suggested that Executive Council extend letters in support of the success of the Canadian Naval Memorial Trust Battle of the Atlantic Place Project and the Sydney Mines Tourism Development Society project, both of which were presented to NS/NU Command Convention.

That the letters in support of the success of the projects, be extended.

It was noted that this support in no way would permit the use of the Legion logo.

NS/NU Command Immediate Past President Steve Wessel noted that recognition of service by Executive Council Members is carried out at the pre-convention Executive Council meeting without the knowledge of that service brought before the delegates to Convention. In discussion it was agreed that NS/NU Command Honours and Awards Committee would consider that beginning at the 2019 Convention, awards be presented to Committee Chairmen at the conclusion of that Chairmens' report to delegates on the convention floor.

It was noted that the Legion Youth Leadership Training Camp closing is scheduled for July 02 6:00 pm at the Alumni Theatre, Dalhousie Universty Campus, Truro and that all Executive Council Members would receive an invitation and are strongly encouraged to attend in order to gain a full understanding as to the

tremendous benefit of the program. The meeting heard from Comrade Robert Hoeg, District C Commander, about his experience as a participant of the program. He related that before his training at the Leadership Camp he would not have had the confidence to speak in public and that among other things, the experience led him to further involvement in Remembrance activities and The Royal Canadian Legion. He stated that perhaps to foster increased participation the dates of the camp should be revisited. He suggested that opportunity to have participants make public their Camp experience should be utilized as well as the promotion of Legion membership to participants and their families.

NS/NU Command 2nd Vice President Marion Fryday-Cook advised the meeting that District E election will be held June 11.

2nd VP Fryday-Cook reminded the meeting that the subject of reports to the 2019 Command Convention begins as of this meeting to cover the 2 year term.

2017 Track and Field Chairman Comrade Hoeg, advised that he will send an e-mail with details of the Legion Trial meet in the hope that Executive Council Members will attend to help promote The Royal Canadian Legion.

8. Date/Time Next Executive Council Meeting

NS/NU Command Chairman Karen Lynch advised that the next meeting of Executive Council is scheduled for Saturday September 16, 2017 to convene at 8:15 am for a meeting start of 8:30 am. She advised that dress for the meeting will be Legion dress with medals as official photo will be taken. Those without report are to ensure to indicate through the Executive Director of no report for the meeting and that for the September meeting Districts will report verbally. Chairman Lynch stressed the importance of adhering to deadlines and that Executive Council will be advised and reminded of those deadlines and all requirements via e-mail.
