Application to Host NS/NU Command Convention 2023

NS/NU Command President Marion Fryday-Cook notified the meeting that an application to host the 2023 Convention from Branch 128 Whitney Pier had been received. She advised that a site visit had been conducted as well as a meeting with Branch potential LAC Chairmen and that

Branch facilities were found to meet the requirements with all amenities required fully available in the surrounding area.

She cited the example that this current convention is titled the 55 biennial convention which would mark 110 years of NS/NU Command conventions which is not so.

It was agreed that votes during Business Sessions, other than by ballot, will be recorded by show of hands or by a standing vote.

On behalf of the Finance and Building Committee Chairman Donna McRury reviewed with the meeting recommended changes to the Branch Monthly Financial Report.

NS/NU Command Finance and Building Committee Chairman Donna McRury advised the meeting that the approved accessibility modifications and minor building renovations as approved are underway at the Command building. She also suggested that the next term C&L Committee consider the separation of Finance and Building and that perhaps a Building Chairman be given the responsibility for maintenance and projects related to the actual building.

NS/NU Command C&L Committee Chairman Donna McRury advised the meeting that only one section of the NS/NU Command Policy Book has not yet been updated.

NS/NU Command Sports Committee Chairman Robert Hoeg advised the meeting that he once again represented NS/NU Command at the annual Frank Duchene Golf Tournament. He explained that funds raised are donated to the NS/NU Command Benevolent Fund and that more should be done to encourage Legion member entrants in the tournament. He advised that the 2021 tournament raised \$4,000.00. Comrade Hoeg noted that he would add this information and request member support during his Sports Committee report at Convention and committed to assisting in raising awareness around the tournament for 2022.

NS/NU Command Cadet Medal of Excellence Committee Chairman Don McCumber provided the meeting with an update on the changes to the selection process proposed by DND. The meeting agreed that NS/NU Commands' position on the issue remains unchanged and that a meeting take place between the Cadet Program representatives and NS/NU Command representatives to make NS/NU Commands' position clear.

District C Commander Hoeg questioned the need to reply all when registering an electronic vote and requested that the policy which dictates that requirement be reviewed. It was suggested that given the Executive Director chooses the option of a delivery receipt when issuing the email that perhaps the requirement to acknowledge receipt could be eliminated.

NS/NU Command President Marion Fryday-Cook extended great thanks to Comrades Richard Malin, Comrade Cliff MacIntyre and Don McCumber for their service to NS/NU Command and their Districts.

President Fryday-Cook thanked Comrade Karen Lynch for her dedication and commitment to NS/NU Command and for her encouragement and support. President Fryday-Cook also recognized that Comrade Lynch was the first women to serve as NS/NU Command Chairman.
