Nova Scotia/Nunavut Command Chairman Tom Young called the meeting to order at 6:00 pm.

### 1. Opening Ritual

## 2. Legion Track and Field National Championship 2022

NS/NU Command Sports Committee Chairman Robert Hoeg referred the meeting to the material circulated in advance outlining procedures and protocols that will be in place and identifying procedures and protocols requiring input and commitment from Commands relating to implications of covid-19 for the 2022 Legion National Track and Field Championship.

In discussion points were raised as to risk, differing provincial protocols around isolation and prevention, all due care and responsibility, liability and cost, especially if Athletes, Coaches and/or Chaperones were to become ill or exposed to covid-19. Given the Championship takes place in August, it was suggested that the decision on whether to participate this year could be delayed.

Sports Committee Chairman Hoeg explained that notice and planning of trials to be held in July, calls for Coaches, Chaperones and registration of athletes are initiated by Athletics NS beginning mid February each year.

Chairman Hoeg advised the meeting that he will not attend the Championship this year.

It was agreed that the Track and Field Championship national meeting scheduled for February 10 will be attended with the information and clarification on outstanding issues from that meeting brought back to NS/NU Executive Council for decision on participation in this years' event as soon as possible.

# 3. Permission RCL Branch 116 Loan Agreement

NS/NU Command Treasurer Conrad Gilbert, with reference to material submitted by Branch 116 distributed in advance of the meeting, provided Executive Council with a synopsis of the financial status of Branch 116 noting that all required financial statements were up to date. It was noted that all documentation required by Executive Council in consideration of the request was provided.
