

NS/NU Command Executive Council

Service Bureau Report

Our bureau is dealing with Veterans Affairs Canada (VAC) disability applications, reviews/appeals and Benevolent fund applications.

Since 1 Jan and as of 30 Aug 2019:

- we are handling 372 open/active VAC files (note 1)
- we made 34 home visits (note 2)
- we had 226 favorable and 21 unfavorable VAC disability claim decisions
- we had 80 VAC disability claims withdrawn (note 3)
- we have been responsible for approx. \$11.3 million dollars awarded. Which is the equivalent to financial lump sums for VAC disability claims (note 4). As important to these monetary pay outs are the medical benefits given to each person for the rest of their life.

Note 1 - This includes Disability claims (first applications and departmental reviews), but also such things as Veterans Independence Program applications, Caregiver Recognition Benefit applications, Survivor applications, etc.

Note 2 - Complicated VAC cases which are Command clients who request to work on VAC forms in their home as they are not able to travel to our office due to mobility/medical issues. Also, weekly Veteran Farm Project deliveries since 11 Jul.

Note 3 - Claims are withdrawn for various reasons such as Veterans moving and not forwarding new contact information or Veterans not following through with their responsibilities in the process after an excess of a 5 months of assistance.

Note 4 - For the entirety of 2018 we were responsible for 11.5 million dollars awarded and we have almost surpassed that in 8 months of 2019.

Since the last report our Bureau Service Officers attended a Military Transition Center Stakeholder Meeting, presented at the Command Information Session, the CFB Halifax Second Career Information Session, the Halifax Operational Stress and Injury Social Support group and the Command Convention. They also, conducted annual Service Officer Training and participated in National Service Officer teleconferences. They are also scheduled to attend the Eastern Service Officer Professional Development Seminar in Montreal QC and have been invited to present at an information session sponsored by the Halifax and Region Military Family Resource Center.

On behalf of the Command Service Bureau, thanks to all the Branch Service Officers, Branch Executive and members for their dedication and determination. Also, to the Command Executive for their unwavering support. The work of the Service Bureau would not be accomplished without all your assistance.

Finance Report:

July's Financial report was sent out to the members for your preview. As you can see Command is continuing to stay relatively within the respected budget. Where there are area's that are over budget however NS/NU Command finances overall is not over budget.

The next GIC's that are up for renewal will be March 2020 and August 2020. Executive Council will be informed of what is being offered closer to the respected dates.

Comrade Gilbert will speak to the Branch's Finances as well.

Building Report:

Reference: Executive Council meeting January 27, 2019

Whereas, past Chairman Tofflemire brought forward three projects in his report for Councils consideration, which consisted of:

#1 Install an additional heat pump with three heads for the two service officers and the Executive Directors office, work to be done by; MacDow Mechanical Ltd has quoted a price for the system installed at \$ 8,450.00 plus HST.

Committee members met on June 27th at 5:30pm:

Discussion was held pertaining to the projects that needed to be addressed:

Comrade Gilbert made inquiries to this company to for an updated quote and the company came back with \$8850.00 + tax = \$ 10178.00 this would be the same unit that is already installed at Command. It's BTU's 24000 3-7000 BTU heads. Install would take 1.5 days

4 companies had been canvassed for price comparison. The company that completed the work was the same company that done the previous heat pumps.

Recommendation from the Building Committee was to:

Install Fujitsu M# Aou24rlxfz outdoor unit on the left wall of building, 8' off the ground 20' back from the front of the building. The company would install Fujitsu M# Asu7rlf1 heads in the 3 offices on the left side of the building. The electrical would be ran through the attic from the panel to the outdoor unit. Fujitsu units come with 12-year parts and 10-year labor warranty backed by the manufacture. Price to have this system installed would be \$ 8,850.00 plus HST;

An electronic vote took place to:

NS/NU Command Executive Council voted in favor of the proposed recommendation of the Building and Finance Committee. Work was completed.

#2 The main entrance door is not meet the Accessibility Act for Nova Scotia:

The Finance and Building Committee met August 27th to discuss the accessibility to Command Building.

As a Committee we agreed that as the entrance to the building is not fully wheelchair accessible, 3 quotes be sought, with intention of having accessibility parking space created next to the building garage door where there is appropriate accessibility and a buzzer and intercom. Comrade Steadman agreed to seek out potential grants and report those findings at the next meeting. Comrade Gilbert agree to have the quotes available for consideration by the Committee not later than December with the intent of including the cost in the proposed Finance and Building budget of 2020.

#3 The building corner drain project:

It was noted that the water runoff from the down spout at the parking lot side of the building creates a minor ice buildup that could prove hazardous. We agreed that Comrade Gilbert will provide the Committee with 3 quotes to resolve the issue, including re-routing the downspout to a non-traffic area. It was agreed that the quotes would be available for consideration at the next meeting of the Committee with the intention of including the cost in the 2020 Finance and Building Committee proposed budget.

#4 Executive Director and Treasurers laptop:

The Finance and Building Committee had a discussion in great length pertaining to the two laptops. We, the Committee made a recommendation to Executive Council to purchase 2 laptops for the offices of Executive Director and Treasurers. The prices that were quoted for the Laptops had increased since it

was a sale price and the fact that the sale was over it did cost more. With the approval of Command President and the Finance and Building Chairman, the Executive director was to order the laptop, programs and have the technician install what is required for the office to be able to do the job that needs to be done. The total cost which includes a new laptop, new programs, technician to install with labor and extended warranty came to \$1530.08 Comrades the system that the Executive Director has now should last for a few years to come. Also, with this new system it has the space and capability to be able to do the updates that happen without threat of having the system crash.

The Treasurers new laptop cost 803.85, this is a Dell computer with extra warranty on it as well. With the extra warranty, any issues would be looked after. The Finance and Building Committee believe that with the new heat pumps to keep the entire Command office at a healthy temperature and the fact that the new computers that are in the offices, we have eliminated the stresses that would happen daily. I have had the privilege of speaking with the staff pertaining to the heat pumps and computers and they are all relieved and very appreciative of all that has been done.

#2 Front Door Lock and Entrance:

Repairs are need to the front door of the office. Comrade Gilbert contacted a company to engage in the necessary repairs needed. The company has yet to contact the Executive Director to arrange for a date to complete the work. Comrade Gilbert will contact the company with a request to contact the Executive Director to schedule a date for the job to be done.

Moving forward, I feel that the building is in good shape with hopefully no major repairs needed for some time.



Zone 2, Cape Breton District A, Nova Scotia/Nunavut Command Report

September 14, 2019

Zone 2 consists of 9 Branches stretching from Sydney to Louisbourg and Dominion to Port Morien. The Branches in Zone 2 are Branch 003 - Glace Bay, Branch 005 - Donkin, Branch 12 – Sydney, Branch 15 - New Waterford, Branch 55 - Port Morien, Branch 62 – Louisbourg, Branch 78 - Dominion, Branch 128 – Whitney Pier, Branch 138 – Ashby.

The Branches in Zones 2 are generally doing well. Most branches are financially stable and able to meet their monetary obligations. Getting financial statements has improved greatly (99%) from a last year but sometimes you still have to get after one or two for late returns. There are, however, some branches that are struggling to make ends meet and are able to exist because of the hard work on the part of a few members who are making the commitment to the Legion, their branch and the Veterans. Most branches are doing either BINGO or Chase the Ace to raise revenue. Other branches in the Zone are doing well with hall rentals, dances and a weekly or monthly breakfast or supper. Almost all branches in the Zone have done some kind of renovation last year to their facility in part to fund raising and Government Grants more will continue this year.

Membership continues to be a concern in most branches in Zone 2. Renewal percentages are on average 96.5% compared to last year in Zone 2. Two branches in the zone have exceeded 100% renewals while the remaining seven branches range from 85% to 96% renewals over last year's membership. Incorrect member addresses are being updated by the branch members and we hope to have it rectified by the next meeting.

Most of the branches remain dedicated to attending monthly District meetings and take an active role in the affairs of the District.

Branch 78 Dominion hosted the Dominion Command Dart tournament in May 2019. This event had a great turnout and was supported by most branches in the Zone.

The Past President of Br 138 Tom Young is the LAC chair of the Royal Canadian Legion National Youth Track and Field Championships starting this year and running for the next 2 years. A excellent turn out of Veterans were on hand with the 2 levels of Government, Provincial and Municipal showing up at The University Of Cape Breton to present Medals to the athletes. Branch 138, the surrounding branches and Tom Young should be commended for the work they have done to make the first year of these games a great success.

As we all know not all Branch Members and Executives get along. In May of this year I stepped in and closed Branch 015 for 1 month as the executive had all resigned. After an election, a new executive was put in place and the legion opened again. Branch 15 is still going through some serious business, but I am keeping an eye on it and informing Command on everything that goes on at the branch.

Comrade Don. This is my short version of Zone 13. I could go into much more detail for each Branch but I do not think that is necessary. Sufficient to say that we need more volunteers but I have no idea where they would come from.

LUNENBURG BRANCH 23

. This branch is doing fairly well. The Branch has a weekly Bingo and every other month visits the Fisherman's Memorial Veteran's Unit to cook breakfast for the Veteran's. It has weekly Dart and Pool Tournaments. As with other Branches in the Zone, Branch 23 is hurting for volunteers.

BRIDGEWATER BRANCH 24

As with other Branches, this Branch still lacks the more interested full time volunteers. They have a very active Catering Committee which provides meals every Friday evening for TGIF and for weddings and various banquets. They financially support 62 Niobe Sea Cadets and 2688 Kinsmen Royal Canadian Army Cadets. They have an active Sports Committee which supports Crib, Darts and Pool tournaments.

The Veterans Outreach Programs of NS/NU Command are constantly evolving, with new programs starting, new initiatives starting to come along and take shape, as well as the programs that have been in place for the past number of years getting renewed with more veterans wanting to attend. We must keep pace with the changes that are affecting the everyday lives of our Veterans and their families.

Over the years VOP has supported projects directed towards the good mental health of our ill and injured Veterans. Healing on the fly is located in Eastern Passage and in Windsor. In addition, fly tying kits and rods were procured for upcoming programs having us well situated for expansion throughout the province. Our Fly Casting Clinic was held on June 1st at Aylesford Lake Provincial Park. We were very fortunate to have Lewis Hinks (FFI Master Fly Casting Instructor) and Rene Aucoin (FFI Master Fly Casting Instructor in training) volunteer their time to instruct our fly casting clinic. The event was very personalized to the participants and beneficial to all. I would like to thank Lewis and Rene for volunteering their time for this worthy cause. The Margaree Fishing Trip, we were very fortunate to find guides that volunteered their time to take us out fishing during this trip. In total we had 2 guides, 4 volunteers, 3 still serving participants and 5 Veteran participants. The group went fishing for 4 hours in AM and 4 hours in PM which left ample time to coord a tour of the Salmon Museum and some fly tying in between fishing. The impact this trip had on the participants was huge. There was a lot of peer support and just genuine brotherhood that would be difficult to replicate.

The PTSD Painting Therapy Program has just been renewed and is located in Sydney and meets regularly with a full class of 11 Veterans. Plans are underway to expand this program to the Valley and South Shore areas.

The Veterans Farm Project is going strongly, the name of the farm is Sweet Squish farms and is located in Sweets Corner, Hants Corner. Starting in June and every week since, the Veterans Farm Project has delivered food boxes to the Command Office for the distribution to Veterans and their families facing food insecurity. The farm is a space for woman to heal, be nurtured and engage and do something positive. About a dozen woman currently come out to help on the farm through out the week, socialize and relax. There is also activities they can partake in also like Yoga, Baking, Archery and other workshops. The Veterans working on the farm have benefited greatly and the recipients are most grateful to receive this nutritious bounty. They pick vegetables every Wednesday, which are then packaged and delivered to the Command Office. NS/NU Command provided the Veterans Farm Project with a donation that helped cover their first year of operation, of tools and seeds.

Paws Fur Thought completed August with its 7th pairing of NS Veterans and their dogs, with was supported by NS/NU Command with 2 more scheduled in October.

Operation Vet-Build, a model building program for Veterans and their families operating mostly in Ontario currently will be expanding to Sydney (Dominion Legion) in the Fall with the hope that the program can be replicated elsewhere within the Command. I have spoken to Craig Hood of the BSO/OSI Special Section and he is looking forward to getting this project going, you can look this project up on Facebook.

Finally, plans are underway for the annual OSISS Family Peer Retreat and will be reported when confirmed at the next executive council meeting.
