# 6. Minutes of Executive Council Meetings

NS/NU Command Chairman Tom Young called for errors and omissions from the minutes of the Executive Council Meeting of February 24, 2024.

NS/NU Chairman Tom Young informed the meeting of an omission of the motion to accept the recommendation of VSRB Editor Comrade Steve Wessel to approve Option three of the new contract.

NS/NU Command President Don McCumber presented the three options for the 2025-27 VSRB that were provided to VSRB Editor Steve Wessel by Fenety Marketing:

# We have the following options for a new three year contract from 2025-2027 for your Command Legion's consideration:

<u>All projected revenues below are based on our generating the same sales /</u> <u>collections as we have for our 2023 project.</u>

**1.** Market a reduced number of 2,500 hard copies, versus our current 3,000 copies, with a 3% increase in Fenety Marketing's gross commissions and the elimination of our \$2,500 yearly new contract signing bonus, to offset Fenety Marketing's increased operating costs and reduced project revenues. This would result in a reduction in your Command's annual net earnings of (-\$15,981) to <u>\$67,155</u>, versus your final net earnings of \$<u>83,136.54</u> from our 2023 project.

2. *Market a Digital Copy only version of your book* under the exact same terms and conditions as our last 5 year contract. Your Command's net earnings would remain in the range of \$83,000.

We would sell advertising and gain residential sponsorship for an online "digital" publication only and no longer print a hard copy book, but provide links for all of our project's sponsors and your members to access the online version. Businesses purchase "institutional advertising" from us to support a good cause, not to increase their business. The exposure they get on your website along with our annual certificate of appreciation and a link to your publication will be equally well sponsored as purchasing advertising in a hard copy.

We have also acquired new "Flip Book" software that makes our online versions much easier to read by turning the pages like a hard copy, instead of the previous PDF's we have been providing. Individual Copies could also be printed from your website. We will be converting the books currently on your site to Flip Book versions in the near future.

So we can provide the exact same terms and conditions to the Nova Scotia Nunavut Command Legion by eliminating the costs of printing and distribution of hard copy publications. *I am offering this option to all of our valued clients, if the funding they receive from our project is more important than producing hard copies of our annual guide.* 

3. **Market a Hybrid Digital / Hard Copy Book** and print only 1,000 hard copies for your branches. Surprisingly the costs of printing 1,000 copies versus 2,500 copies is only 15% less expensive, as the main costs is in the set up of the printing, including making the plates, etc., etc. Fenety Marketing would increase our gross share of revenues by only 2% and eliminate our annual \$2,500 new contract signing bonus. This would result in annual net earnings of **\$71,650 or (-\$11,487) less** for your Command.

**ARTICLE IX – TRUSTEES 901 A** The Executive Council shall appoint three Members to be a Board of Trustees to administer any monies or other assets given or bequeathed to the Command and held in Trust, upon the terms and conditions and for the purposes specified by the Page 23 NS/NU Command By-Laws Donor, Testator or Settler and the Board must submit an annual inventory report to Command on the property, building and contents by the end of the fiscal year.

A meeting was subsequently held between the trustees and the Sub-Executive and the terms of reference were reviewed. The trustees were informed where the funds were deposited. There were no conditions attached to the \$332,540.63 bequest and there was a slight condition attached to the \$50,000 bequest that it be used where most needed, so it was deposited into the Benevolent Fund.

In future Article IX – Trustees 901 A of The Nova Scotia/Nunavut Command Bylaws must be adhered to.

# 18. President's Closing Remarks

NS/NU Command President Don McCumber expressed concern that only Executive Members have been attending Zone and District meetings and that in order for members to take on executive positions in the future we need for them to attend the meetings so that they have an understanding of the positions. He suggested inviting guest speakers to help to draw other members to attend.

He added that he has been waiting over a year to get a response via the Minister of Public Works to get a response to having the three years of service requirement removed from the Veterans' Plate application. #### NS/NU Command Executive Council Veterans Services Report

Veterans Services is dealing with Veterans Affairs Canada (VAC) disability applications, reviews/appeals and when requested assist with Benevolent fund applications.

#### In 2024 (2024-01-01 to 2024-04-30):

- We are handling 783 Veterans Affairs Canada (VAC) files (note 1)
- We have had 8 favorable and 1 unfavorable VAC disability claim decisions.
- We have had 1 VAC disability claims withdrawn (note 3)
- We were responsible for over \$286,644.80 dollars awarded. Which is the equivalent to financial lump sums for VAC disability claims. 8 new monthly pensions and increases. As important to these monetary pay outs are the medical benefits given to each person for the rest of their life.

In 2023:

- We handled 795 Veterans Affairs Canada (VAC) files (note 1)
- We made 70 home visits (note 2)
- We had 227 favorable and 28 unfavorable VAC disability claim decisions.
- We had 70 VAC disability claims withdrawn (note 3)
- We were responsible for over \$17,924,398.47 dollars awarded. Which is the equivalent to financial lump sums for VAC disability claims., 9 new monthly pensions and increases. As important to these monetary pay outs are the medical benefits given to each person for the rest of their life.

Note 1 - This includes Disability claims (first applications and departmental reviews), but also such things as Veterans Independence Program applications, Caregiver Recognition Benefit applications, Survivor applications, etc. Note 2 - Complicated VAC cases which are Command clients who request to work on VAC forms in their home as they are not able to travel to our office due to mobility/medical issues. Also, weekly Veteran Farm Project deliveries between 11 Jul and 19 Sep 2019.

Note 3 - Claims are withdrawn for various reasons such as Veterans moving and not forwarding new contact information or Veterans not following through with their responsibilities in the process after an excess of 5 months of assistance.

In March 2024, we brought on the New Service Officer at NSNU Command, Dana McLellan, where we began her onboarding and training. The number of files continues to increase, but with training now having been completed, and Dana now having started the second phase of the training which involves more hands-on approach, the hope is to see those numbers become stabilize within the next few months. On behalf of the Command Veterans Services, thanks to all Branch Service Officers, Branch Executive and members for their dedication and determination. Also, to the Command Executive for their unwavering support. The work of the Veterans Services would not be accomplished without all your assistance.

work closely with Marion Fryday-Cook who sits on the Dominion Committee. Please start now to organize a Branch event to recognize this milestone of our 100<sup>th</sup> Legion Anniversary.

There are issues that need to be addressed within our Command. One is the issue of outstanding Financial Reports. Branches must be accountable for the finances of the Branch. 

Photographs should be .5 to 1 megabyte in size. Larger photographs can be reduced to Legion Criteria, a too small photograph will distort when enlarged.

(c) Some photographs taken by these cameras, when adjusted to magazine requirements turn to be out of focus or blurred by camera shake. If Cell phone and iPad cameras were quality cameras, camera manufacturers would not be making cameras costing upwards of

five hundred to ten thousand dollars. Branches should supply a suitable digital camera to their Public Relations Comrade to take a quality photograph.

The staff at Camp Hill continue to provide remembrance and memorial services for out Veterans. The Zone 15 Sgt-at-Arms, Comrade Richard Powell, continues to represent Command at the monthly memorial services (last Monday). January's service was rescheduled to 5 Feb which was also cancelled, both due to snowstorms however they got back on track on 26 February.

The Sgt-at-Arms advised that the February service was "awesome". There was 65 people present which included veteran patients, family and friends of those passed away, staff and those involved with the service. Camp Hill has decided to hold the services every other month starting in March of this year. This decision was made because each month there is a significant drop in families attending. As has been done in the past, Earl Francis Memorial Branch in Spryfield attended to read off the names of the lost ships and rang the bell. There was no requirement for a Colour Party. The staff continue to provide meaningful services that provide our veterans with the opportunity to remember and share these services with their family and friends.

The Exec Dir advised of a request received from the Ombud's office to asssit a visually impaired veteran at Camp Hill. I made contact with the veteran, we spoke about his needs/expectations (he is also extremely hard of hearing) and we have been able to provide a volunteer (with the tech skills to assist) the veteran in managing his correspondence, appointments, etc. at least once a week.







The Veterans Outreach Programs of NS/NU Command are constantly evolving around our Veterans changing requirements in order to remain relevant. We must keep pace with the changes that are affecting the lives of our Veterans and their families. A few of our programs that have come to the forefront over the years are going strong and are supported strongly by our Veterans, for in-person and virtual meetings they are thriving, we also have started doing virtual corresponding, such as the Veterans Coffee Break. Here is a snapshot of what is going on around the Command and how they are supporting our Veterans.

The committee had a meeting the first week of May and discussed the following current programs and look forward to new programs within NS/NU Command.

#### **OSISS**

The Operational Stress Injury Social Support program is a service that supports our active Canadian Armed Forces members, our veteran community and their families. OSISS is a peer support program funded both by the Department of National Defence and Veterans Affairs Canada.

They provide peer support to members, veterans and their families who experience symptoms from an operational stress injury (ie PTSD, anxiety, depression, and/or addiction) as a result of their service. We have two types of

coordinators in the program; a peer support coordinator who is a military veteran who has personally experienced a mental health injury due to their service; and, family peer support coordinators, who have lived experience in supporting a loved one with an OSI. Because we have similar lived experience, we are able to establish trusting, confidential professional relationships with peers and support them in a non-judgmental, empathetic way.

It was discussed with the committee that we open our programs to include the families of the participants of the Veterans coffee break groups and Op Vet Build.

## Heros Mending on the Fly

HMOTF is having a substantial growth to the program this year with 3 new locations to run the program in addition to HRM and the Valley. New locations are Wedgeport, Truro and Chetticamp. They are planning on hosting 8 participants in each location for a total of 40 veterans. This is only possible through the support we get from HMOTF National, NS/NU Command and many local Legions in NS. They have also included first aid training and mental health first aid training for the volunteers this past year. We feel this is important to properly equip our volunteers to lead the participants while always looking after their wellbeing. The HMOTF team was busy all winter with fly tying and are now at the stage where they started to do fly rod casting training which was conducted last weekend. This will lead up to the final stage which is to go fly fishing. If any member would like to see the progress HMOTF they could go to the Website for updates.

### **Veterans Farm Project**

The Veteran Farm Project Society was established in 2018 for women veterans to spend time together in safe, natural, and enriching environment. We have expanded our programs each year and offer a variety of programs and opportunities to spend time on the farm.

Since 2018 the Veteran Farm Project has supported nearly 150 families and nearly 700 individuals through the Royal Canadian Legion Nova Scotia/Nunavut Command, Windsor Legion as the hub for Valley Branches, and both Shearwater and Greenwood MFRC's. Each We Care package delivered contains farm fresh produce, multiple breads, pantry staples, and personal care items. We curate each delivery based on seasonal produce and time of year. We ensure each recipient can create full meals with items delivered.

All items that are carefully delivered is put together by a collection of amazing women veteran volunteers and community members. Our program is designed to reach women and girls and giving them the space to grow and explore. We believe in the power of nature and the benefits it provides. We work to provide volunteer opportunities and free workshops that focus on many different areas for personal growth. Therapeutic horticulture and informal peer support are ways to deliver cognitive, physical, emotional, social, and creative pathways to help heal mind, body, and spirit. We believe in cultivating wellness for women veterans, veterans, and our community.

## **Buddy Check Coffee**

What is Buddy Check Coffee? BCC is a very simple concept, a scheduled regular get together of veterans that is coordinated and co-marketed by a local host who is a member of BSO Legion OSI. It provides peer support for veterans. BCC is held in a location chosen by the local HOST. It can be a local Legion Branch or a commercial coffee shop. We are here to serve all veterans. NS/NU Command have reached more than 60 Legions that hold a Veterans Coffee Break.

## **Op VetBuild**

Is still going strong at most branches that participate in the program. I have talked to a few of the Legion host branches, and they are reporting great turn outs and that some will be shutting down for the summer months but will pick back up in the fall.

## New Programs for the Future

At the Veterans Outreach committee meeting we discussed a few new programs which were forwarded to NS/NU Command for support; and the committee will be looking into these:

> Emeritus Golf

> Audeamus Service Dogs/ White Lake Service Dogs

> NS Wildlife Carvers/Artists Assoc

> The need to provide better support to women veterans and families.

Comrades, these are just a few of the programs which the Executive Director and the Veterans Outreach Committee will be looking into but require more information.

Included as an addendum to my Feb. report was a letter dated 9 Feb 2024 regarding the new VSRB contract with Fenety Marketing, sent by email to Comrade McCumber, **to be discussed as business at the Feb E.C. meeting.** Through conversation with Comrade McCumber, I have been informed that the letter was presented to Council, discussed, and my proposal regarding the various contract options presented by Fenety, was duly accepted by motion!

My dilemma is as follows – I have no means at my disposal, other than through this report, to raise any *"errors or omissions*" to the minutes of 24 Feb 2024. The minutes simply state that the submitted VSRB report was referred to and carried (M-29).

There is no record in the minutes of the following:

- The letter of 9 Feb 2024, its contents or who presented it to Council
- Any discussion that took place regarding the VSRB contract options
- The motion that was presented regarding the acceptance of the specific option (#3) to the new contract.

I have sent a copy of this report to Chairman Young in hopes that he will address this issue before the Feb E.C. minutes are put to a motion for acceptance at the May E.C. meeting.

Comrades, this contract is a legal document between Fenety Marketing and NS/NUC and deserves, is required, to be documented in the official record of our Command.
